Kentucky is “the” pioneer and national leader in most aspects of K-12 education technology over the past 30 years; however, we’ve always had the mindset that we are far from 100% perfect and thus have continuously improved since the birth of the Kentucky Education Technology System (KETS) in 1992. It’s also crucial to know that the size and scope of KY K-12 technology is 8 times larger than the rest of KY state and local government combined and uses 25 times more Internet than the rest of KY state government combined. Few Fortune 100 companies have a bigger tech footprint and service responsibility than KY K-12’s edtech systems.

OET has a very flat organizational structure with an Office of the CIO and three Divisions with no Branches. OET is responsible for the following for all 171 districts, all of KDE the agency including KSB and KSD:

- Ensure technology properly supports the school district’s education plans and digital readiness, and the Commissioner’s and the Kentucky Board of Education’s (KBE) vision/educational goals.
- Ensure basic and equitable anytime, anywhere, always-on access to instructional and administrative edtech services are provided to students, teachers, administrators, parents, and the general public.
- Build and maintain productive customer relationships with school and district leadership, and establish and maximize external partnerships (e.g., with edtech vendors, state agencies and universities).
- Evaluate and implement emerging technologies and trends that may assist with educational needs; manage/maximize edtech funding and resource opportunities.
- Stay current and open to emerging technology and trends that may assist with educational needs; manage/maximize edtech resource opportunities.
- Manage policies and legislation to maximize the equitable and effective use of edtech: and
- Maximize data use. Continue to improve data quality. Champion data security & privacy best practices.

- Leads KDE and district support for the Kentucky Student Information System (Infinite Campus).
- Facilitates KDE's data diet initiatives including the elimination of collection and use of Social Security Numbers.
- Leads KDE's K-12 data governance.
- Oversees deployment of the annual KY School Report Card Suite.
- Leads initiatives to maximize data quality and promote effective data use.
- Provides data visualization tools for schools and self-service data research tools.
- Co-leads KDE's data privacy efforts; facilitates and promotes best practices for data sharing by KDE.
- Coordinates legislatively-required federal and state reporting, and assists districts with their Civil Rights Data Collection (CRDC) reporting.
- Leads Kentucky's statewide e-Transcripts program supporting high school students, counselors, and college admissions officers.

- Promotes solutions to maximize secure use of data, interoperability between systems, and eliminate the need for redundant data collections.

- Leads the safety and security services for all districts and KDE (Lightspeed content management/protection, cyberattack firewalls, denial of service prevention).
- Provides edtech Help Desk/Service Desk for all 171 public schools, KSD, KSB and KDE.
- Provide Enterprise ERP MUNIS (KY K-12's financial mgt system) cloud service for all 171 public schools and KDE.
- Education software development to support Kentucky educators. Web applications for schools.
- Involved with Kentucky Educator Credentialing System (KECS) transition and transition/implementation of KY K-12's new identity management system (i.e., Connected User Experience System (CUES)).
